The EMPRESA DE ACUEDUCTO Y ALCANTARILLADO DE BOGOTA – ESP (EAAB) intends to apply for financing in the amount of US\$480 million (Phase I US\$58.34million and Phase II US\$421.66 million) equivalent from the World Bank toward the cost of the WASTEWATER MANAGEMENT FOR ENVIRONMENTAL RESTAURATION AND WATER SECURITY IN THE BOGOTA RIVER BASIN PROJECT, and it intends to apply part of the proceeds to payments for a Concession contract, and consulting services to be procured under this project. This project will be jointly financed by the Development Bank of Latin America (CAF).

The Phase I will include the following components:

Component 1 - Innovation in Wastewater Management (US\$ 34.66 million, of which US\$ 23.91 million will be financed by IBRD, US\$ 5.98 million will be financed by CAF, and US\$ 4.77 million will be financed by EAAB). This component will build on EAAB's recent work to promote innovation and expand existing tools for wastewater management and strengthen EAAB's capacity to manage the construction of large WWTP through data management and analytics tools, an industrial effluent monitoring pilot, a sludge dewatering construction and operation pilot, the strengthening of EAAB institutional capacity for contract management and a contract supervision management firm.

Component 2: Wastewater Treatment Infrastructure Management Capacity (US\$ 43.04 million, of which US\$ 34.43 million will be financed by IBRD and US\$ 8.61 million by CAF). The objective of this component is to finance activities before the construction of the Canoas WWTP as part of the concession contract. These include preliminary work activities and adaptation of the land where the construction of the future Canoas WWTP will take place. These activities will allow the construction of the treatment infrastructure in each of its stages to be carried out without problems once the designs are ready for construction. The activities financed under this component will include: (i) topographic surveying and construction staking; (ii) provisional enclosures; (iii) excavations, (iv) fills; and (v) loading and removal of excavation material and surplus.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank Procurement Regulations for IPF Borrowers (Regulations) November 2020 and is open to all eligible bidders/consultants as defined in the Regulations.

Specific procurement notices for contracts to be bid under the World Bank's international competitive bidding (ICB) procedures and for contracts for consultancy services will be announced, as they become available, in [UN Development Business](#), [dgMarket](#), "El Tiempo" newspaper, "Diario La República" newspaper, and newsletter to all media: radio, press and television.

Prequalification of suppliers and contractors will be required for the following contracts.
